

# POLICIES, GUIDELINES & WAIVERS

## General Expectations

- Be on time to class. If you are more than 10 minutes late, you will not be permitted to enter class.
- Use the toilet and get water before entering class.
- Students in Dance Prep must be fully potty-trained.
- Snacks are not permitted in class. Water bottles are welcomed.
- Respect yourselves, others, and our shared space during class by listening to the teacher, keeping your hands to yourselves, and treating the studio mirrors, barres, and other equipment with care & respect. Do not hang on the barres.
- Do not enter the studio before class begins or when the door is closed. Wait for your teacher to enter the studio.
- Parents are requested to refrain from entering or observing classes (even through windows or crack in door) to prevent student distraction unless the instructor has invited visitors.

## Dress Code

- Arrive in proper dance attire, as described in the Dress Code, for the class, including shoes on, and hair tied back.
- Jewelry and hair accessories (other than that needed to tie back hair) are not permitted in any classes.

## Missed Classes/Refund Policy

- There are no refunds or make-ups offered for missed classes for any reason.
- The first class may be paid at the drop-in rate if desired. Thereafter, payment is required for the full term. After term payment has been, no refunds are offered for students who decide to withdraw for any reason.
- Refunds (prorated for the number of classes taken) will be given in the event that a class is canceled due to not reaching minimum required enrollment (5 students at Bodytree, 6 at Saadiyat Beach Club) after the first month of the term.

## Spring Recital (April 27)

- Term tuition does not include recital fees or tickets.
- Recital participation is optional; sign-ups, ticket sales, and costume payments will be announced in early February and required for participants by Feb. 23.
- Student who miss more than 3 total classes during Term 2 or the last 2 classes before the recital may not be allowed to participate, regardless of whether fees have been paid or not. Costume fees paid are non-refundable.
